#### Annual Business Meeting Minutes - 2023 January 22, 2023

The annual business meeting of Glory Baptist Church was held on Sunday, January 22, 2023 following the morning service. Mat Nix presided, Pastor Chris opened in prayer.

Joey McGuire, church clerk, read the church covenant from our constitution and the minutes of the mid-year meeting held in July. Roy Egstad made a motion to approve the minutes, Ardis Flowers second, carried. The agenda was reviewed and Connie Pearson made a motion to approve the agenda, John Pearson second, carried.

Pastor Chris, on behalf of the deacon board, presented Bill and Joanie Haas for membership. Steve Pearson made a motion to accept them for membership, Gayle Gilbertson second, carried.

The reports from boards and committees were presented in written form and there was time allotted to read them. Discussion was held about some updates or clarification to the reports. Evon Pearson made a motion to approve the reports as presented, Sandy Pearson second, carried.

#### New Business:

Church Pianist Update - Jack Gilbertson - We are trying to find someone to play the piano on a regular basis for our Sunday morning services. The worship and music committee has looked internally and externally and has not been able to find a person. The committee is recommending that this be a paid position. The worship team is working on implementing digital music accompaniment that we will be seeing on Sunday mornings soon. We currently have 2 people playing that will fill in for songs when we do not use digital accompaniment. The church council is in agreement that we pay \$100.00 per week for a church pianist. Al Pearson clarified that this expense is included in the 2023 budget.

New Pew Bibles - We are in need of new Bibles for our worship center. The expense will be approximately \$2,000.00. This will be put on the special projects list. We need volunteers to work on this project, let the trustees know if you would like to work on this project.

Emergency Preparedness Partnerships - Joey McGuire mentioned that during the winter storm that left many without power at home we did have power at the church. She is offering to meet with the county organizations that we need to partner with to become a community resource in time of emergency.

Gary Bradford mentioned that we could check with the area colleges to see if we can get a music student intern to provide accompaniment during the summer months. He also said he would like to see a children's choir started.

Financial Report - Sandy Pearson clarified some of the line items from the financial report. General fund giving is down about 9% from the prior year. Steve Pearson mentioned that inflation accounts for most of that and we need to consider increasing our giving to offset that increase in expenses. Ardis Flowers made a motion to approve the financial report, Evon Pearson second, *Contil next page*

carried.

Review and approve 2023 budget - The budget committee met and made adjustments to the budget in areas they saw appropriate. The new budget shows an increase of about \$5,000.00. Major changes were a \$10,500 increase for Pastor Chris and dropping the youth pastor salary to \$10,500 for this year. Mat Nix shared some graphs showing some of the trends and changes of our financial situation for the past few years. Evon Pearson asked if we could have a midyear statement of giving for people to assess what they have given. Al Pearson gave a report on how the budget has been developed in recent years. Katie Nix brought some concerns about the amount budgeted for this year. It was clarified that the youth pastor amount was adjusted because we do not expect to have a youth pastor for more than one-half of the year. Elaine Moser recommended having the amount given be posted in the bulletin on a monthly basis. Mat Nix brought up the possibility of not adding the increase to Pastor Chris's salary, only due to budget constraints. Al Pearson mentioned that there was no raise given in 2022 and recommended we leave that raise in place. Al Pearson made a motion to approve the budget as presented, Joey McGuire second, carried.

Nominating committee - Al Pearson presented the 2023 ballot. We still have a few open positions to be filled. Ruth Egstad made a motion to accept the ballot as presented, Sandy Pearson second, carried.

Pastor Chris closed the meeting in prayer.

Meeting adjourned.

Safety Committee – Vicki Daniels – The safety committee met this last week. They would like to request that the church becomes part of "Ministry Safe" which does training to prevent sexual abuse. The committee came up with five basic areas to focus on. 1. Food Safety

- 2. Child & Youth Safety
- 3. Property Safety
- 4. Security
- 5. Emergency Response

Trustees – Mathew Nix – D.O.T. inspection passed. Al Pearson is planning to fix the brakes. Our heat pumps have not been working properly. We are waiting on McGuire mechanical on what the findings are. If there are any issues, please let the trustees know.

Financial Report - Sandy Pearson went over the printed financial report and answered questions that arose. Mid-year financial statements were sent out this year. Faith Promise is down. Debbie Haroldson is training to be the next treasurer and doing a great job. Sandy thinks we should think about a capital account for major issues such as a/c and heating issues. Update check signers for COOM account – A motion was made by Bill Haas that we remove Kevin Pietz from any or all accounts where he is a signer. It was seconded by Al Pearson. Motion carried.

Recommendations from Youth Advisory Group on your pastor search – The Youth Advisory have been meeting as a group regularly. The proposal is that we, as a church, select a church committee that would search for a family pastor, not just a youth pastor. Pastor Chris made a motion that we select a pulpit committee to begin that search process. Evon seconded.

Discussion: What will need to be decided: time commitment, job description, compensation. Evon Pearson – we need a youth pastor and someone to do more for families, but questions whether we need someone with the title pastor vs. a ministry leader. Pastor Chris – the reality is that this is a process that will likely take a year or more. Vicki Daniels – Could the upper room be a home for this potential worker if needed? Gary Bradford – Thinks the position is too broad.

Process for forming the committee: Mat Nix suggested we give it two weeks for people to think about joining the pulpit committee and then have a short meeting again to recruit five members. Vote... Motion carried.

Other Discussion:

Bill Haas – Capital budgeting. Maybe we could use any surplus money at the end of the year and put in a certain percent.

Rollie Flowers – Thank yous! Thank you Will for helping with putting the picnic shelter tin up. And thank you to everyone around here helping.

Al Pearson made a motion to adjourn.

In 2024, if funds are available, we hope to get electricity installed in the pavilion. #### Women's Ministry Annual Report from 2023

Quilters meet in the lower auditorium each Tuesday morning.

Lu Thiessen generously donated her belongings to WM for a garage and rummage sale. Many of us gathered at her place and prepared/priced and sold her wonderful things. Keeping back all her (41 boxes) Christmas decorations for possible use at church. Later we decided to have a Christmas rummage sale on opening of deer hunting season. Both sales were enjoyed with fellowship and coffee with the community and ourselves. Our profits from the sales were over \$3,600. With Lu's passion for missions, we immediately sent \$1,000 to Dave and April Cousins (a former youth pastor at Glory) in Senegal for a special project.

Our Christmas Luncheon resorted back to former Covid years with full salad and dessert luncheon served in the gym. Our guest speaker, Arlene Gabrielson, presented a gospel message with theme "Joy in the Chaos". We were blessed with 130 guests which didn't include the about 20 additional women or men who were in attendance to help. Shari and Cameo Jensen provided the music for the program.

Glory women are included in the Christian Women outreach area meetings on the 3rd Thursday of each month at Wahkon Inn. It includes a dinner, special speaker from Stone Craft Ministries, and special event presentation.
